A. Mission Statement

C. Goals and Objectives:

ii. iii. Strengthening Local Economy: Promote economic development and prosperity within the community by supporting local businesses, creating job opportunities, attracting investment, and building entrepreneurship capacity. Sakhisizwe 's goal is to stimulate sustainable economic growth and reduce dependency on external resources.

iv. Building Community Capacity: It is Sakhisizwe 's aim to empower individuals, groups, and organizations within the community to take an active role in decision-making, problem-solving, and resource mobilization. This can involve providing training, fostering leadership skills, promoting civic engagement, and supporting community-based organizations.

v. Enhancing Infrastructure and Services: Sakhisizwe is keen to improve the physical infrastructure of the community, including transportation, utilities, public spaces, and recreational facilities.

viii. It is Sakhisizwe CDF's aim to address the specific needs and challenges faced by marginalized or vulnerable groups within our community, such as women, youth, elderly, persons with disabilities, and minority populations. Ensure their inclusion, representation, and active participation in community development processes.

D. The Programme has five strategic pillars to help meet it objectives.

Early Childhood Development and Educare

Early childhood development refers to the physical, cognitive, social, and emotional growth and learning that occurs in children from birth to around the age of 8. This period is crucial for laying the foundation for our children's future well-being and success. Early childhood development encompasses various aspects of a child's development, including language acquisition, motor skills, problem-solving abilities, social interactions, and emotional regulation.

Sakhisizwe 's main aim of early childhood development and educare is to ensure that our children have a strong foundation for future learning and success. By providing a nurturing and stimulating environment, our children will be able to develop their cognitive, social, emotional, and physical skills, setting them up for a lifetime of learning and well-being.

Educare, on the other hand, is our approach to early childhood education that focuses on providing comprehensive care and education to our young children. It goes beyond traditional day care or preschool settings and aims to create a nurturing and stimulating environment that supports children's holistic development. Our Educare programs will integrate early learning, health, nutrition, and family support services to ensure that our children receive all the necessary elements for their optimal growth.

As part of our Educare program we will prioritize the following components:

We will put emphasis on age-appropriate learning experiences that promote cognitive skills, language development, literacy, numeracy, problem-solving, and critical thinking. The programs will also provide opportunities for exploration.n, creativity, and hands-on learning.

Health and nutrition: As part of the Educare program we recognise the importance of physical wellbeing in a child's development. These programs often offer nutritious meals and snacks, regular health check-ups, immunizations, and access to healthcare services. They also promote healthy habits and hygiene practices.

Social-emotional development: It our aim to place significant emphasis on fostering children's social and emotional skills. They provide opportunities for positive social interactions, promote empathy, emotional regulation, and self-confidence.

Family involvement and support: We seek to acknowledge the vital role of families in children's development. Our programs will actively engage parents and caregivers, providing resources and support for their involvement in their child's education. We aim to offer parent education, workshops, and encourage regular communication between educators and families.

ii. Primary and Secondary Education and Learning

Our Secondary education refers to the educational stage that follows primary education and will cover the ages of 12 to 18. Sakhisizwe CDF regard this as a critical phase of education where student transition from childhood to adolescence and prepare for higher education or entry into the workforce.

Whilst our secondary school students will be provided with a broad and balanced curriculum, building upon the foundational knowledge and skills acquired in primary education. We aim to help and support our students to have the opportunity to select elective courses based on their interests and future goals by way of choosing subjects relevant for the modern day living and working environment and having in mind the advanced technology required in the job market.

Students to be more focussed in their learning and to take advantage of the teaching methods designed to promote critical thinking, problem-solving, and analytical skills. Moreover, we are aware that secondary education encourages students to take greater responsibility for their own learning, develop time management skills, and become independent learners, skills they will need to use later in the working industry.

We aim to help the students to not focus only on academic development but to support their' personal and social growth, by supporting and encouraging the school to provide extracurricular activities, clubs, sports, and community service opportunities to foster teamwork, leadership, and interpersonal skills. Additionally, to encourage schools and support them to have guidance counselling services available to assist students in making informed decisions about their future educational and career paths whilst removing themselves from a culture of fuelling crime and violence in our school. In addition awareness programmes to help young people to surf the web safely and to be able to use social media platforms careful to avoid sexual exploitation and drug trafficking.

By so doing the above students will be well prepared for higher education, vocational training, or entry into the workforce. At the end of their secondary years, they will be equipped with the necessary knowledge, skills, and competencies to pursue their chosen paths successfully and become responsible citizens in society.

iii. Substance Misuse, Protection of vulnerable adults and Community Support

This is a fundamental component or key area of focus within a larger framework that represents a principle that guides efforts to address and tackle substance misuse and its impact in our community. We aim to identify different key areas of focus relating specifically to our Cata village. This pillar represents different aspects that need to be addressed comprehensively in our community to effectively prevent, and address substance misuse and its associated deadly consequences as already experienced by our community in the recent years and months.

We aim to use a comprehensive approach to substance misuse and community-related issues involving several key issues such as:

Prevention: The focus will be on implementing strategies and interventions to prevent substance misuse from occurring in the first place. Such strategies will involve educational programs, awareness campaigns, promoting healthy lifestyles, and implementing guidelines for the community to restrict access to substances.

Treatment and Recovery: The emphases will be on providing information and support in accessing treatment services for individuals struggling with substance misuse.

Harm Reduction: The main aim will be to minimize the negative consequences associated with substance misuse. This will involve implementing strategies such as outreach services to reduce risks to those families who are affected directly by substance misuse, by protecting vulnerable children and adults living with these individuals and promote safety amongst affected individuals, their families and the community at large.

Law Enforcement and Legal Measures: This will involve enforcing laws and regulations related to substance misuse, such as regulating the sale and distribution of substances, implementing penalties for illegal activities, and combating drug trafficking.

Community Engagement and Support: This will put emphasis to the importance of community involvement, collaboration, and support in addressing substance misuse. It is vital for Sakhisizwe CDF to build partnerships with community organizations, providing resources and support to affected individuals and families, and fostering a supportive and inclusive environment.

These key issues collectively will form a comprehensive approach to addressing substance misuse and community-related issues, with each pillar contributing to a broader strategy aimed at prevention, treatment, harm reduction, law enforcement, and community support.

iii. Vulnerable adults and Community support refers to a key area of focus within a larger framework aimed at addressing the needs, protection, and well-being of vulnerable adults in our community, as well as providing necessary support systems to ensure the safety of our children, older and elderly vulnerable community members with inclusion, and empowerment.

Vulnerable children and adults are individuals who may be at risk of harm, abuse, neglect, or exploitation due to factors such as age, disability, mental health issues, cognitive impairment, or even resulting in their substance misuse of their family members. This pillar will recognise the importance of safeguarding their rights, promoting the independence, and facilitating access to appropriate support services for all those vulnerable people in our community.

Our key elements associated with this pillar will be:

Safeguarding and Protection: Sakhisizwe CDF will focus on identifying and addressing risks and vulnerabilities faced by both children and adults in our community. Our program will involve implementing measures to prevent abuse, neglect, and exploitation, as well as establishing reporting

mechanisms and intervention protocols to respond to concerns and protect our vulnerable children and adults from harm.

Collaborative Partnerships: Sakhisizwe CDF recognizes the importance of collaboration among different stakeholders, including government agencies, healthcare providers, law enforcement, community groups, and volunteers. Working together will ensure a coordinated approach to support vulnerable adults and provides a network of resources and expertise.
